Terms of Reference

The **Anti-Ragging Monitoring Cell** shall be responsible for:

- (a) Monitoring and overseeing the implementation of the University's Anti-Ragging Policy.
- (b) Taking preventive measures to ensure a ragging-free campus and hostel environment.
- (c) Creating awareness among students regarding the consequences of ragging and the applicable rules and regulations.
- (d) Monitoring complaints or reports relating to ragging and ensuring that such matters are promptly brought before the competent authority for appropriate action.
- (e) Coordinating with the Anti-Ragging Committee, hostel administration, security personnel, counsellors, and other concerned stakeholders, whenever required.
- (f) Ensuring appropriate counselling and support to students affected by incidents of ragging.
- (g) Maintaining necessary records and documentation relating to anti-ragging activities, complaints, and actions taken.
- (h) Submitting periodic reports and recommendations to the competent authority of the University regarding the status of anti-ragging measures.
- (i) Performing any other functions assigned by the Vice-Chancellor or the competent authority in connection with the prevention and monitoring of ragging.

The Cell shall function in accordance with the applicable UGC Regulations, directions of the statutory regulatory authorities, and the rules and policies of the University, as amended from time to time.
